I have the honour to forward herewith the Annual Report of the Department of Land Records for the year ending 31st July 1912.

2. In the Northern Division much of Mr. Mehta's time was taken up with the work of the Talukdari Surveys which are now drawing to a close.

In the Central Division Mr. Gordon's tour and work were much interfered with by ill health which finally made it necessary for him to take leave after the end of May. But as will be seen from the body of the report he did much useful work of a permanent nature before he went.

Mr. Wiles in the Southern Division did a good year's work and toured with activity.

3. My office establishment has worked hard and well under the able and untiring supervision of my office Superintendent, Mr. Zuzarte.

Department of Land Records.

CHAPTER I.

PREFATORY.

The charge of the Department was held by me throughout the year, except for a period of two months and 10 days from 1st August to 10th October 1911, when Mr. J. McNeill, I. C. S., was in charge.

2. The offices of the Superintendents, Land Records and Registration, Northern, Central and Southern Divisions, were held by the following officers for the periods specified against them:—

Khán Bahádur P. R. Mehta, M. R. A. C., held charge of the office of the Assistant Settlement Officer, Tálukdari Survey, throughout the year.

- Mr. J. A. McIver held charge of the office of the Superintendent, Government Photozinco Department, from 1st August 1911 to 13th March 1912 from which date he proceeded on combined leave. Mr. A. W. Audy was in charge of the office for the rest of the year.
- 3. During the period under report Mr. McNeill visited three Districts. I toured in 17 Districts (including the Districts of Thar and Parkar, Hyderabad, Karáchi, Sukkur, Upper Sind Frontier and Lárkána in Sind) for inspection, inquiries and arrangement of working plans with the local officers especially in those Districts which were confronted with problems of peculiar difficulty. Particular attention was given to Sind where I toured for a month in February and March and I again visited Karáchi in June to meet a Conference of District Officers which was assembled by the Commissioner in Sind. The Conference lasted 5 days and resulted in the settlement of many important questions of Land Records and Land Revenue Administration. It was also decided to make a beginning in the following fair season of the measurement of sub-divisions in Sind.

Superintendents' movements and supervision.

4. All the Superintendents toured in their respective charges for the supervision and inspection of the work of the Land Records Staff, Record-of-Rights and the measurement of sub-divisions.

CHAPTER II.

LAND RECORDS ESTABLISHMENT.

Establishments under the Divisional Superintendents.

5. Besides their own establishments and the establishments of the District Survey Offices, the Field parties worked under the immediate control and

supervision of the Superintendents and their work is described in Chapter III of this Report.

Training of Junior Civilians.

6. Four Junior Civilians and one Probationary Deputy Collector underwent a course of instruction in survey and settlement matters in their respective districts under the supervision of the Divisional Superintendents. Three of these officers were declared to have duly qualified themselves.

Training of Circle Inspectors in Survey.

- 7. Central classes for the training of Circle Inspectors in Survey were opened in Poona and Belgaum. The Thána Circle Inspectors who have been trained at Belgaum were trained at Poona which is for them a more convenient centre. No class could be held in the Gujarát districts owing to the prevalence of famine. The classes were as usual conducted by the Field Party Surveyors under the general supervision of the Superintendents. After preliminary instruction the candidates underwent a practical course in measuring at the Divisional Head Quarters under the surveyors and an independent course of measurement in their own districts under the District Inspectors. On the conclusion of this course the candidates were examined by the Superintendents.
- 8. Of the six candidates from the Thána district, four passed the survey test while two completely passed the Circle Inspector's Examination. In the Central Division out of the 21 candidates 14 passed the survey test, but only 11 were declared to have completely passed the Circle Inspector's Examination. Of the 41 candidates who attended the class at Belgaum 22 passed the Survey test, while the number who completely passed the Circle Inspector's Examination was 17.
- 9. Classes for the training of Village Accountants continue to remain in abeyance.

District Survey Offices.

10. The number of District Survey Offices remains the same as in the previous year. With a view to more efficient management all the District Survey Offices in the Central and Southern Divisions have now been placed under the entire control of the Superintendents. All the offices were inspected in detail by the Superintendents, and their work was found to be on the whole satisfactory. The records of the Thána Office referred to in last year's report have not yet been rearranged by the Superintendent's establishment and it appears that the work may require the employment of a small special establishment. The matter is receiving attention.

The system under which the establishments now employed in the various District Survey Offices are recruited and promoted appears to need reform. The Superintendents have represented that it is difficult under existing conditions to keep up the efficiency of the offices as the older and more experienced men retire. The matter will receive special attention and will be referred to again in next year's report.

District Inspectors.

11. The normal programme of duties was in many districts disturbed by famine and scarcity, but statement IV shows the work performed by the District Inspectors of Land Records. They appear on the whole to have done a sufficient amount of routine inspection and the Collectors are satisfied with the way in which they have performed their duties.

In the Northern Division Mr. C. D. Kavi, District Inspector of Ahmedabad, is specially praised by the Collector and the Superintendent. In spite of extra duties entailed by famine he succeeded in disposing of a large amount of useful work. In the Central Division the Collector praises the work of Mr. K. M. Vaishampayan, District Inspector of West Khándesh, but notices that his test work was less than it should have been. Mr. Bere, District Inspector of Land

Records, Ahmednagar, an experienced and conscientious officer, died during the year. The work of the other District Inspectors was sufficient and on the whole satisfactory.

12. A class was held at Poona from 11th September to 11th October 1911 for the training of Junior. District, Inspectors in theodolite and plane-table. The class was conducted by Mr. S. R. Bhagwat, L. C. E., Lecturer in Engineer, ing in the College of Engineering. Seven District Inspectors and two candidates for the post of District Inspectors attended the class and all were granted certificates of proficiency.

Circle Inspectors.

Inspectors were relieved of their ordinary duties and were employed on special work entailed by famine and scarcity. And in some districts especially in the Konkan where the revision of the Record of Rights preparatory to re-writing was specially laborious and difficult, important routine duties such as repairs of boundary marks were neglected. The difficulty will in future be met by the employment of special establishments so far as possible, so as to leave the Circle Inspectors free to devote a proper share of attention to all branches of their work.

The Collectors in general speak favourably of the work done by the Circle Inspectors and care is being taken to keep up efficiency of the staff by proper attention to their recruitment, pay and promotion.

- 14. Boundary mark work was entirely suspended on account of famine and scarcity in Ahmedabad, Kaira, Panch Maháls, Dhárwár, in four Talukas of Sholápur, and in parts of Ahmednagar. The programme of repairs was completely carried out in only a few districts among which may be mentioned Satára, Bijápur and Kánara, but in the majority of districts the reports received give no definite information on this point. Mere figures of boundary marks repaired are in themselves of not much value or interest without information as to the extent to which the year's programme of work was actually carried out. Care will be taken to see that next year's reports contain this information and it will be embodied in statement I.
- 15. Statement II gives details of measurement and classification work performed by the Circle Inspectors. Special attention has been given to this work in Satara and a very creditable amount of work has been got through for which the Collector gives special praise to the Acting District Inspector Mr. Yardi. The arrears are still heavy in several districts, but the total amount of work disposed of in the year is in every division greater than in the past year and from many districts reports have been received of the success of the experiment mentioned in last year's report of making one or more selected Circle Inspectors solely responsible for measurement work alone.

The system will be still further developed and extended during the fair season of 1912-13 and will, it is hoped, permanently improve the quality of the work and prevent undue delays in future.

Measurement of sub-divisions.

- 16. The progress made in this work was greater than in any previous year, In the Surát District plane-table surveys were continued under the personal supervision of the Collector, Mr. Anderson. The Bárdoli Táluka, part of which had been mapped last season, was completed, also the whole of the Jálalpur Táluka and 13 villages of the Chorási Táluka. In Thána a special party controlled by the Superintendent of Land Records and Registration, Northern Division, completed all but 5 villages of the Salsette Táluka.
- 17. In the Central Division three special parties of trained measurers were employed under the Superintendent of Land Records and Registration, one in the Kopargaon Taluka of Ahmednagar, another in the Haveli Taluka of Poona and the third in the Barsi Taluka of Sholapur. The details of their work are shown below:—

In addition to the above work, the sub-division measurement work was carried out by parties locally organized in the Khed Táluka of the Poona District, in the Taloda, Nandurbar and Sakri Tálukas and in the Nawapur Petha of West Khándesh and in the Jalgaon and Jamner Tálukas of East Khándesh. These parties measured 22,374 sub-divisions in 154 villages.

- 18. In the Southern Division, the measurement of sub-divisions was carried out principally in the Dhárwár and Bijápur Districts. In the former district, the whole of the Ron Táluka was completed, 20,676 sub-divisions having been dealt with by 27 measurers. In the Bijápur District, the Hungund Táluka begun two years ago was completed by 6 measurers. One village in the Vengurla Táluka of the Ratnágiri District was also finished during the year under report.
 - 19. Special enquiries will be made during the fair season of 1912-13 to ascertain how far the sub-division measurement work done in past years has been kept upto date, and I hope before the end of the season to be ready with proposals for a scheme for securing the regular maintenance of mapping as desired by Government in their review dated July 1912 of the Annual Report for the year 1910-11.
 - 20. I am glad to bring to notice the good work done by Mr. Gordon as Superintendent, Land Records and Registration, Central Division in organizing and training the special measuring parties for sub-division work. He has drawn up a very useful code of technical instructions which will greatly facilitate work in future and will enable us to get better work at smaller cost. Another very useful piece of work performed by Mr. Gordon is a little Handbook or Manual of Land Surveying for Bombay Revenue Officers which I am about to submit to Government. The need of such a book has long been felt and it will be specially useful to Circle Inspectors and Junior Assistant Collectors.
- 21. Much valuable experience gained in the practical work of measuring sub-divisions is now being turned to account in other directions. Practically all the field measurement which our revenue Surveyors have now to deal with, consists of plotting interior detail into the existing frame work of demarcated survey numbers. For this purpose the detailed and elaborate system of survey by triangulation which was reasonable and proper in original surveys, is no longer necessary and can well be replaced by simpler and more summary methods of measurement in the field and the use of the area-square in the office for area calculation. These changes will, without reducing efficiency, make great economies of time and labour both in the field and in the office.

Circle Books.

22. The progress made in the compilation of Circle Books is shown in Statement V. The work is up to date except in two districts of the Northern Division, three districts of the Central Division and four districts of the Southern Division.

CHAPTER III.

SURVEY AND SETTLEMENT WORK.

REVENUE SURVEY WORK.

Northern Division.

- 23. The following Survey Establishments were employed in this Division:—
 - (1) A Field party consisting of 10 permanent surveyors for the Gujarát districts.
 - (2) A Field party of 3 permanent surveyors for the Thána district.

During the Field season both Field Parties were fully employed and the amount of work done by them was adequate, and in the recess season they were employed on the examination of the field work done during the field season.

Survey of the Talukdari Estates.

24. Owing to famine, the number of parties was reduced from five to three who were sent out to do the field work still remaining in the Broach, Kaira and Panch Maháls districts. The operations were severely handicapped by the failure of the rains and the consequent fodder famine and labour difficulties in Broach caused by the emigration of the labouring classes after the partial failure of the cotton and jowári crops. Work was started late and was carried on throughout the season under constant anticipation of interruption by the declaration of famine, which contrary to expectation never became necessary. The amount of work done has declined, but in view of the special difficulties of the season the progress made was satisfactory. The only work now remaining is the measurement of the Vantas in the Broach District and this will be completed by 2 parties during the ensuing field season. The Assistant Settlement Officer makes favourable mention of the work done by the Head Surveyor Mr. Bhailal Hargovandas and by the three Nimtandars, Messrs. Ranchodlal Bapuji, Devshankar Kalidas and Keshavlal Tribhowan.

Central Division.

- 25. The parties which continued to work in this Division were:—
 - (1) The Central Division Field party, and
 - (2) The 2 Additional Field parties.

When the fair season began the surveyors from these parties were drafted off in large numbers to form the nucleus of special parties for the measurement of sub-divisions in the Deccan districts. The remainder were consolidated into one party under one Head Surveyor which carried on the work of survey of Inám villages. This party completely measured 9 Inám villages, partly measured 7 Inám villages and also did the complete classification of 12 Inám villages.

Southern Division.

Of the work done by them during the year special mention may be made of the survey and settlement of Kurundwad and Ganeshpur, the survey of Devache Gothane, the classification of salt lands in the Devgad Taluka and the reclassification for water of irrigated lands in the Ranebennur Taluka. The survey of the Pardi lands in the Ratnagiri District was finally completed. In the Ratnagiri District the Watap Establishment turned out a very large amount of partition work. An important reform carried through this year was the curtailment and simplification of the reports and returns relating to this work and the adoption of a uniform daily fee for measurement work which have largely reduced clerical work.

REVENUE SETTLEMENT WORK.

Northern Division.

27. Original settlement reports of the Khalsa village of Chitrodia in the Jhalod Mahál and of the Inám villages of Majigam (Chikhli Táluka), Walnai and Wadhwan (Sálsette Táluka) and Siadla (Olpad Táluka) were submitted by the Superintendent, Land Records and Registration, and survey rates were introduced in the villages of Dholera (Dhandhuka Táluka) and Oganaj (Daskroi Táluká).

Central Division.

28. Original settlement proposals for 1 Government and 6 alienated villages and revision settlement proposals for 16 alienated villages were submitted by the Superintendent, Land Records and Registration. Revised survey assessments were introduced into 208 villages.

Southern Division.

- 29. Second Revision Settlement proposals for the Kalghatgi and Bankápur Tálukas of the Dhárwár district submitted by the Settlement Officer, Mr. Turner, were received in this office and submitted to the Commissioner. Revised rates were introduced in the tálukas of Dhárwár in the Dhárwár district and Parasgad in the Belgaum district.
- 30. The Survey Daftardár's office with the help of a special establishment completed during the year the work of calculating the Second Revision assessments of the Dhárwár and Parasgad Tálukas.

City Surveys.

31. The inquiry work of the Godhra City Survey is still in progress. An important amendment has recently been made of the District Municipal Act by Act X of 1912. Under this Act subject to a period of one year's limitation for appeals or suits finality is given to orders of a Collector or a Survey Officer deciding claims to property by or against a Municipality. This legislation, will, it is expected, be found very useful to Municipalities in protecting the rights of the public against the encroachments which have hitherto been found such a troublesome problem in Municipal Administration. City surveys will in future years be more freely undertaken in order to secure these benefits, but the difficulty of finding a sufficient number of competent surveyors for this class of work is at present seriously felt.

Government Photozinco Department.

- 32. The work turned out by this Department for the twelve months ending 31st July 1912 was 2,284,268 pulls valued approximately at Rs. 1,36,119-13-11 at a total cost of Rs. 1,00,123-5-3 leaving a balance of Rs. 35,996-8-8 in favour of the Department.
- 33. Useful work was done during the year in production and issue of revised and up-to-date editions of several taluka and district maps.
- 34. The new editions are based upon the Government of India topographical survey sheets and are thus a great improvement on the old táluka maps many of which were based merely upon the Provincial Revenue Surveys.

CHAPTER IV.

RECORD OF RIGHTS.

35. As in the previous year the work in connection with the Record of Rights consisted chiefly in the preparation of a new edition by revision and

rewriting in new forms. Satisfactory progress was made in nearly all districts, but in some the work was delayed or suspended on account of the prevalence of famine conditions. The districts where the heaviest arrears still remain are Kaira in the Northern Division, Poona, Ahmednagar and Sholápur in the Central Division and Bijápur in the Southern Division. This first edition of the Record is now complete in the following districts:—

Northern Division ... Ahmedabad, Panch Maháls, Broach and Surat.

Southern Division ... Belgaum, Kolába and Kánara.

- 36. The orders of Government contained in Government Resolution No. 8965 of 23rd September 1911 made ample provision for the cost of the special establishments required to help the ordinary district staff in this work. The first allotment of Rs. 70,000 was made for the year beginning April 1, 1912, and it began to be utilized from the beginning of March about half way through the year dealt with in this report. Special establishments were entertained in almost every district and have cost up to the date of writing in round figures Rs. 38,000. The money has been very usefully spent and reports from every district continue to show that there has been a great improvement in the standard of accuracy of the new records. In the Thána and Ratnágiri Districts the old records were often so inaccurate that the revision practically amounted to the preparation of a new record based upon a new and careful enquiry in the field. Future revisions will not, it is hoped, be so laborious or so expensive.
- 37. The Record of Rights is now also the Record of Liabilities in nearly every district and this change will to a certain extent automatically make for more careful and regular maintenance and greater accuracy. At the same time care is being taken to insist upon punctual reports by landholders of acquisitions of rights especially by way of partitions and of redemptions of mortgage and to levy deterrent fees in cases of neglect or delay in reporting. It may therefore be expected that the cost of the periodical revision and rewriting of the record will in future be considerably less than it is now in this first revision.

38. The cost of the special establishments employed for the revision of the Record during the year ending 31st July 1912 was Rs. 36,108 as follows:—

- 39. Initial records were compiled for 5 Sharakati villages and for the Poona City and Suburban Municipal areas in the Poona District; for 1 Sharakati village and 7 Municipal areas in the Sátára District; for 4 Sharakati villages and 1 village recently made Khalsa in the Alibag Táluka of the Kolába District and for 4 newly made Khalsa villages, 4 Sharakati villages and 5 Municipal areas in the Ratnágiri District.
- 40. During this year a very useful piece of work has been done by Mr. Wiles, Superintendent, Land Records and Registration, Southern Division, which may be described in his own words:—
 - "During the season I have been in continual correspondence with the Director and the other Superintendents regarding the Record and have embodied in a Manual what, it is hoped, will prove final instructions."

This Manual was revised where necessary by the Commissioners in conference and was recently submitted to Government for approval and publication.

41. The compilation of Standing Orders in the Land Records Department was also thoroughly revised and brought up-to-date and submitted to Government for approval after scrutiny and revision by a conference of Commissioners.

REVENUE DEPARTMENT.

Office of the Commissioner in Sind,
Government House, Karáchi, ¹³/₁₅th February 1913.

- 1. Revised rates of assessment were not introduced in any taluka during the year under report. Appendix A is therefore blank. Proposals for the resettlement of taluka Nasirabad in the Larkana District, tapas Malir, Mal and Thana of the Karachi Taluka in the Karachi District and tapa Kaloi of the Diplo Taluka in the Thar and Parkar District were sanctioned by Government during the year. Those for the resettlement of the Sehwan, Dadu and Johi Talukas in the Larkana District, and Sukkur and Naushahro Abro (now Garhi Yasin) Talukas in the Sukkur District, were submitted to Government during the year, and have since been sanctioned, while those for the remaining talukas of Guni, Badin, Tando Bago and Dero Mohbat of the Hyderabad District, and Naushahro, Moro and Kandiaro of the Nawabshah (formerly Hyderabad) District are still under the Commissioner's consideration, and will be submitted to Government as soon as possible.
- 2. Important changes have been effected in the Head Record Office to give effect to the reforms suggested by the Director of Land Records. These comprise:—
 - (1) A re-arrangement of record-stands and re-distribution of rooms.
 - (2) The appointment of a special establishment of 3 Mappers.
 - (3) The appointment of a special establishment of 6 Munshis for indexing field books and bandis.
 - (4) Raising the appointment of the Head Record Keeper to the grade of Mukhtyárkar.
- 3. Appendix B shows the nature and amount of work done during the year under report and in 1910-1911 in the Survey and Map Departments of the Head Record Office. To facilitate comparison with the previous year's table, the figures for the Jámráo tract are shown separately. Columns 2 to 13 will show that arrears, properly speaking, of correction work, have been wiped out. Altogether, corrections were carried out in the case of 7,385 survey numbers including 3,152 for reservations under sections 37 and 38, Land Revenue Code, as against 6,528 in 1910-1911. Entries for 547 survey numbers were tested in the office of the Superintendent, Land Records and Registration in Sind; errors were found in 9 cases and duly corrected.

The strength of the register-writers' establishment remained unaltered. But two of the writers were engaged for a considerable part of the year on the preparation of a ready-reckoner for calculating assessments. One hundred and fifty-four survey registers were written for Táluka Offices and 407 for the Record Office as against 210 and 224, respectively, in 1910-1911.

4. The total number of maps prepared was 10,258 as against 6,821 in 1910-1911. This large increase is due chiefly to demands from the Jámráo tract, especially from the Executive Engineer. That the office could supply this number of maps is due partly to increased efficiency, but chiefly to the fact that fresh printed copies of the majority of the deh maps from the Photozinco Office are now in stock, and the manual labour of preparing maps to send out to officers is considerably reduced. The rise in the number of maps prepared for printing in Poona (871 as against 608 in 1910-1911 and 203 in 1909-1910) is

entirely due to better organization. The special establishment of 3 Mappers, working since 24th April 1912, is employed in bringing up to date 2 clean copies of all the deh maps—one for the Head Record Office, the other to be sent for reproduction to the Photozinco Office, whenever necessary. One thousand and three hundred copies of maps were prepared during the year to replace torn office-copies as against 826 in 1910-1911. The arrears of the Mapping Department were very largely reduced during the year. The work of the Special Mapping Establishment is not likely to end before December 1913.

Eight hundred and eighty-one requisitions were received from officers for the supply of copies from field-books. Of these, 811 were disposed of as against 634 in the preceding year.

- 5. Appendix C shows details of survey work done by Tapádárs which was received for scrutiny in the Head Record Office. In spite of the fact that no assistance was received from Survey Parties, the figures show considerable increase. One Zabit continued to be employed in checking the bandis and field-books received from Táluka Offices. This man had, on several occasions, to be assisted by one of the register-writers.
- 6. The establishment engaged since November 1910 (Government Resolution No. 10324, dated 14th November 1910) on re-arranging records is progressing satisfactorily. Its labours are expected to end by the close of March 1913.
- 7. Another special establishment of 6 Munshis sanctioned in Government Resolution, Financial Department, No. 1115, dated 26th March 1912, has been working since 24th April 1912 at indexing the field-books and bandis in the Record Office, i. e., the old field-books and bandis of the Survey Department and those received more recently. It is too early yet to speak of the progress of this work as, at the present rate, it will probably occupy the Munshis for several years.
- 8. The permanent re-organization of the Record Office, the consideration of which had been postponed till the arrears had been cleared off by the special establishment and the routine work of the office had been brought into a normal condition, will soon be taken in hand.
- 9. The number of Surveyors employed remained at 5. Owing to the unsatisfactory conditions of the season, and in view of the orders contained in Government Circular, Financial Department, No. 2706, dated 22nd August 1911, no Survey Parties were entertained. All the 5 Surveyors, therefore, worked independently. Measurement work was carried out in Táluka Guni of the Hyderabad District and Táluka Sháhdádpur of the Nawábsháh (formerly Hyderabad) District. One Surveyor was deputed for six weeks to settle a disputed boundary line between Baháwalpur State and Káshmor. Another was deputed for a similar period to prepare a site plan of the Sadar Bázár at Shikárpur and Magsi's village, together with a register of house-sites in these localities.
- 10. Appendix D gives details of the field-work done by the Surveyors and tests thereof taken by the Superintendent. Altogether 3,123 survey numbers with an area of 14,950 acres were measured. Considering the time during which the Surveyors were in the field, the amount of work turned out is very satisfactory. In the 78 survey numbers tested by the Superintendent no error of over 1 per cent. was found.
- 11. In connection with the recess work of Surveyors, entries regarding 140 survey numbers were tested in the Superintendent's Office and no errors were found.
- 12. During his tour the Superintendent tested the measurement of 60 survey numbers newly surveyed by Tapádárs and found an error of over 4 per cent. in 3 cases.
- 13. Survey papers of Revenue Tapádárs in the Thar and Párkar, Upper Sind Frontier, Sukkur, Hyderabad and Karáchi Districts, relating to 3,124 survey numbers were examined. In 583, mistakes were found, which were communicated by the Superintendent to the Sub-Divisional Officers concerned.

- 14. Fourteen Taluka Munshis and Clerks went up for a three months' survey training. As usual, they were trained for one and a half months in Hyderabad and for the remaining month and a half they went into the field and measured 58 survey numbers. The Superintendent tested 12 numbers and found no errors of any importance. These men and one Head Munshi, who had failed in the preceding year, were examined in the middle of December. All passed and were given certificates of proficiency.
- 15. The usual four weeks' Survey Class for Revenue Officers was attended by 2 Assistant Collectors, 1 Deputy Collector and 3 Mukhtyárkars. They all passed the Survey Examination and received certificates.
- 16. The following table shows the results of the Superintendent's examination of Táluka Forms Nos. 35 and 36 and Village Forms Nos. 15 and 16. Details of errors and omissions were forwarded to the Sub-Divisional Officers for transmission to the Mukhtyárkars concerned. In 1,450 cases out of the 1,509 shown in column 5, the errors were slight:—

18. The preparation of a Record-of-Rights was undertaken during the year in the surveyed portion of the Karáchi Táluka of the Thar and Párkar District, in certain dehs of the Rohri and Páno Akil Tálukas of the Sukkur District, referred to at the end of paragraph 23 of the report for 1910-1911, and for the agricultural lands within the municipal limits of Lárkána and Kambar. During the year it was found advisable to have a record prepared for all the agricultural lands situated within the limits of the municipal districts in Sind, and a recommendation was accordingly made to Government for the cancellation of the exemption contained in clause (6) of Government Notification No. 263, dated the 12th January 1904, relating to such lands, and was sanctioned by Government in their Resolution, Revenue Department, No. 5045, dated the 28th May 1912. Arrangements are in progress for the preparation of a Record-of-Rights for such lands.

The completion of the preparation of the record in the Jamesabad Táluka was delayed owing to the difficulty of procuring the presence of several occupants who resided in other tálukas. The work could, however, have been finished much earlier, if it had been undertaken in a more business-like manner by the Mukhtyárkar. The attention of the Collector is being drawn to this fact, and he is being requested to have the work finished off as soon as possible. In Rohri and Kambar none of the entries made in the Record-of-Rights has yet been tested, whilst in Páno Akil 1,234 entries still remain to be tested. The attention of the Collectors of Sukkur and Lárkána is being drawn to this, and they are being asked to have all the entries tested by the Supervising Tapádárs concerned, as soon as possible. The Collector of Sukkur reports that in his district a Record-of-Rights has still to be prepared in one deh of the Ghotki Táluka, and that the question of ownership of the disputed land in the deh is still pending and will be decided soon. The Record-of-Rights has now been introduced throughout the Province, excluding the Desert and Kohistan tracts, which are exempt from the operation of the Act.

20. Appendix E, which has been prepared in the revised form in accordance with the orders contained in Government memorandum No. 6901, dated the 26th July 1912, shows the test of Tapádárs' and Supervising Tapádárs' inspection work by Sub-Divisional Officers. The appendix does not contain complete information of all the tests taken as, in some places, no regular record was kept of them. The District Officers are being requested to direct their Sub-Divisional Officers to keep a more accurate record in future.

The Sub-Divisional Officer, Tatta, checked only 200 entries made in Form I-O of the Karáchi Táluka during the year. The total number of entries made in the Record was 3,449. Thus the percentage of the Sub-Divisional Officer's test (5.8) was far below the percentage prescribed, viz., 10 per cent. No tests at all were taken by the Sub-Divisional Officer, Rohri, of the Record prepared during the year in the Rohri and Páno Akil Tálukas. He has been directed to attend to this work without delay. With regard to the Record-of-Rights work in connection with the agricultural lands within municipal limits in Lárkána and Kambar separate figures of tests have not been supplied by the Collector. He is being asked to see that the Sub-Divisional Officer, Lárkána, takes a test of not less than 10 per cent. in each case.

No extra establishment was entertained for any of the other talukas in which the Record was prepared.

- 23. In the case of the Jamesabad Táluka the Mukhtyárkar was assisted by his Head Munshi in the test work and for this purpose 30 dehs of the táluka were constituted into a mahál under section 7 of the Land Revenue Code, and the Head Munshi was appointed Mahálkari for the area.
- 24. The maintenance of the Record is receiving due attention. The Collector of Karáchi reports that in all the tálukas where the Record was promulgated in the previous year it is being kept up satisfactorily except in Tálukas Mirpur Sákro and Ghorábári, and that the attention of the Assistant Collector, Tatta, has been drawn to this fact. Similarly the maintenance of the Record-of-Rights in the Nausháhro Táluka of the Nausháhro Division is reported to be unsatisfactory. But it is hoped that the introduction of the new system of accounts in that táluka from the current revenue year will result in the mutations being brought up to date and the Record being thereafter properly

maintained. The Superintendent, Land Records and Registration in Sind, gives the following opinion on the question of the maintenance of the Record-of-Rights in Sind:—

"During the last three years I find a great improvement in the quality of the Record-of-Rights work. Mistakes are not infrequent, but the Tapádárs understand their responsibilities better and the holders of rights also seem to realize the importance of the Record. The system of using the Record as the basis of revenue accounts appears to have considerable success."

As reported last year the land-holders are recognizing slowly the importance and practical value of the Record. In several cases fines were inflicted under section 8 of the Record-of-Rights Act for failure to make such reports.

In the Johi Táluka of the Lárkána District, Kashmor and Kandhkot Tálukas of the Upper Sind Frontier District, and Khipro Táluka of the Thar and Párkar District, the Record has been fair-copied and promulgated since the close of the year.

- 26. The provisions of sections 10 to 12 of the Record-of-Rights Act were applied during the year to the agricultural lands situated within the municipal limits of Rohri, Ghotki, Garhi Yásin and Sukkur in the Sukkur District, the Sir Amani tract of the Sháhdádpur Táluka of the Upper Sind Frontier District and the Sinjhoro and Digri Tálukas of the Thar and Párkar and Hyderabad Districts (now Nawábshah and Thar and Párkar Districts respectively). They have also been applied, since the close of the year, to the Karáchi, Jati and Sháhbandar Tálukas of the Karáchi District, deh Khudi of the Hála Táluka of the Hyderabad District and the Nasrat Táluka of the Hyderabad (now Nawábshah) District. Proposals for the extension of the provisions of these sections to Táluka Tando Allahyar of the Hyderabad District, Táluka Sháhdádpur of the Hyderabad (now Nawábshah) District and Tálukas Kashmor and Kandhkot of the Upper Sind Frontier District will shortly be submitted to Government.

Arrangements have been made for its introduction this year into all the remaining tálukas of the Province except two, viz., Jamesabad and Sháhdádpur (Upper Sind Frontier District).

29. A conference was held at Government House, Karáchi, in June 1912. at which the Settlement Commissioner, the Heads of the districts in Sind, and the Superintendent, Land Records and Registration in Sind, attended to discuss several questions connected with the Land Records and Land Revenue Administration of the Province. It was decided at this conference to do away with the duplication of Village Form No. I-C referred to in paragraph 30 of the previous year's report and to substitute for the Settlement Register a simple land register to be maintained at the Head Record Office, containing information regarding survey numbers and their areas, and areas under village sites, canals, railways, etc. It was also decided to abolish Village Form No. I-D, Part II, which was sanctioned in Government Resolution No. 623, dated the 21st January 1911, and to omit the Khátedár's name from Village Form No. III (Numbershumari) and to utilize column 9 of the latter (name of occupant, etc.) for making entries of the names of tenants and conditions of tenancy. This change has been ordered to be made from the current year in all the talukas where the revenue accounts have to be prepared on the basis of the Record-of-Rights. The most important decision unanimously arrived at by the conference was to give the sub-divisions of survey numbers, when demarcated, the status of survey numbers for the purposes of remissions and fallows.
